magical lamia ziadé tells the story of the explosion as she experienced it from afar but in the heart a book of love mourning and anger elle on the evening of august 4 2020 an explosion tore through beirut leaving nearly 200 people dead 6 000 injured and 300 000 homeless the blast was caused by storing thousands of tons of ammonium nitrate alongside a stash of fireworks a deadly arrangement about which the government had known but done nothing for six months straight french lebanese author and artist lamia ziadé wrote illustrated and recorded every new piece of information every photograph of the wreckage or the wounded in my port of beirut ziadé weaves together the play by play of the tragedy and the history of lebanon with her own personal stories and her participation in the 2019 protests against state corruption laying out the historical and political background that made such a catastrophe possible and perhaps inevitable lamia ziadé is a lebanese author illustrator and visual artist born in beirut in 1968 and raised during the lebanese civil war she moved to paris at 18 to study graphic arts she then worked as a designer for jean paul gaultier exhibited her art in numerous galleries internationally and went on to publish several illustrated books including ma très grande mélancolie arabe which won the prix france liban Ô nuit ô mes yeux and bye bye babylone

symbolism and what it tells us about the aspirations of the institution within the existing ecclesiastical hierarchy the thrones also reveal much about the personal circumstances of an individual bishop and where he stood on the scale of a good diocesan on the one hand and ambitious politician on the other as exemplified at Exeter and Durham the text is by the art historian Dr Charles Tracy a seasoned expert on church furniture both in Britain and on the continent of Europe the chapter on the stone thrones was prepared by Andrew Budge who is currently preparing a PhD thesis on English chantry churches at Birkbeck College the polychromy authority Eddie Sinclair spent many hours on the scaffold to bring forward her remarkable report on the Exeter throne her full report is to be published online the Exeter throne is also interpreted by the established timber conservation practitioner Hugh Harrison and the St David's throne by the experienced draughtsman Peter Ferguson in an age of the CAD his meticulous measured drawings of the Exeter and St David's monuments are one of the most remarkable features of book the architect Paul Woodfield prepared the drawings for the Lincoln chair
